ANNUAL GENERAL MEETING

The annual general meeting of the home owners is planned for Sunday, September 9, 2018 at 5:00 PM. COVENANT CORNER

Please check your trees for limbs overhanging sidewalks and mailboxes. The Postal Service reports that they find it difficult to make deliveries at some homes because of overhanging limbs. In addition, neighbors cannot easily walk along the sidewalks. If you have trees near a street light, the EMC reports that the homeowner is responsible for maintaining the trees so that they do not block the light. The same holds true for traffic signs.

SHUTTERS, MAILBOXES & PRESSURE WASHING: Many shutters are in bad need of a new coat of paint. Mail boxes are molding and need a good cleaning or replacement. Several homes have gone from their beautiful color to green from mold. Pressure washing can resolve this issue and bring your home back to its original beautiful color.

STREET PARKING for periods longer than six hours is prohibited. This is a covenant issue and you may be fined for this violation. Most neighbors abide by this rule but there are a few exceptions, i.e. residents that don't think this applies to them. It does and needs to be corrected.

There are some issues that are not within the authority of the HOA or Board- i.e. domestic issues, loose animals, neighborly disputes, etc. These issues need to be handled directly or reported to the proper authorities for resolution as the HOA is not capable of intervening in situations beyond the authority designated in the covenants.

If you must park in your driveway, be sure your vehicle is locked at night and when unattended.
